## State Water Resources Control Board (SWRCB) Kern County Subbasin (KCS) Probationary Process Update

Morgan Campbell reported that while the State Water Resources Control Board (SWRCB) tentatively announced the Kern County Subbasin's (KCS) probationary hearing will occur in April 2024, there are assumed schedule delays due to the SWRCB not yet releasing Tulare Lake Subbasin's probationary hearing notice. KCS GSAs continue to coordinate their efforts to address the Department of Water Resources' (DWR) inadequate determination letter. To date, efforts have been focused on developing a unified sustainable management criteria (SMC) methodology for the chronic lowering of groundwater levels. No Board action was taken.

## Addition of Representative Monitoring Well (RMW)

Morgan Campbell reported that written landowner permission was received to incorporate an additional well into WDWA GSA's representative monitoring network. No Board action was taken.
